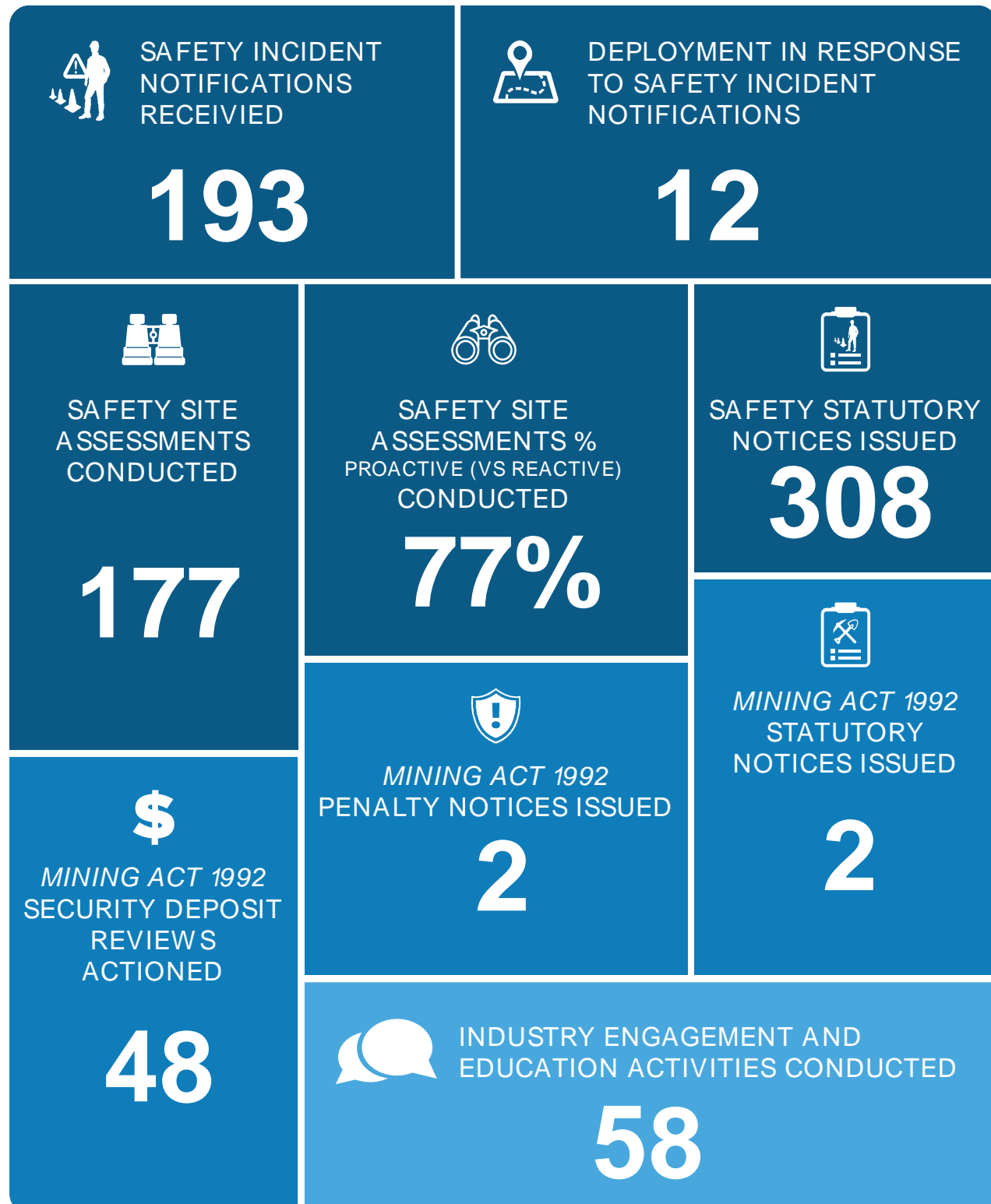

Activities at a glance

Summary of our regulatory activities in March 2021



Key activities

The NSW Resources Regulator published the following in response to three safety incidents of note:

- an [investigation release](#) concerning injuries sustained by a worker when they were pinned by a boom of a continuous miner at Myuna Colliery, Lake Macquarie
- an [investigation release](#) relating to a worker who was injured by failed components during mobile jaw crusher maintenance at Buckaroo Mine near Mudgee NSW and a
- [safety bulletin](#) providing advice to industry in response to the increase in number of reported incidents involving tracked dozers.

We also published an [evaluation report](#) on the Mine Safety Advisory Council Dust Safety Awareness Campaign, 'Take action to prevent dust disease' which ran in July last year.

Stakeholder [feedback](#) was also sought on draft guidelines to help leaseholders comply with the new operational rehabilitation reform requirements.

Two penalty notices totalling \$5000 were issued to Taronga Mines Pty Ltd for failing to pay rents and levies.

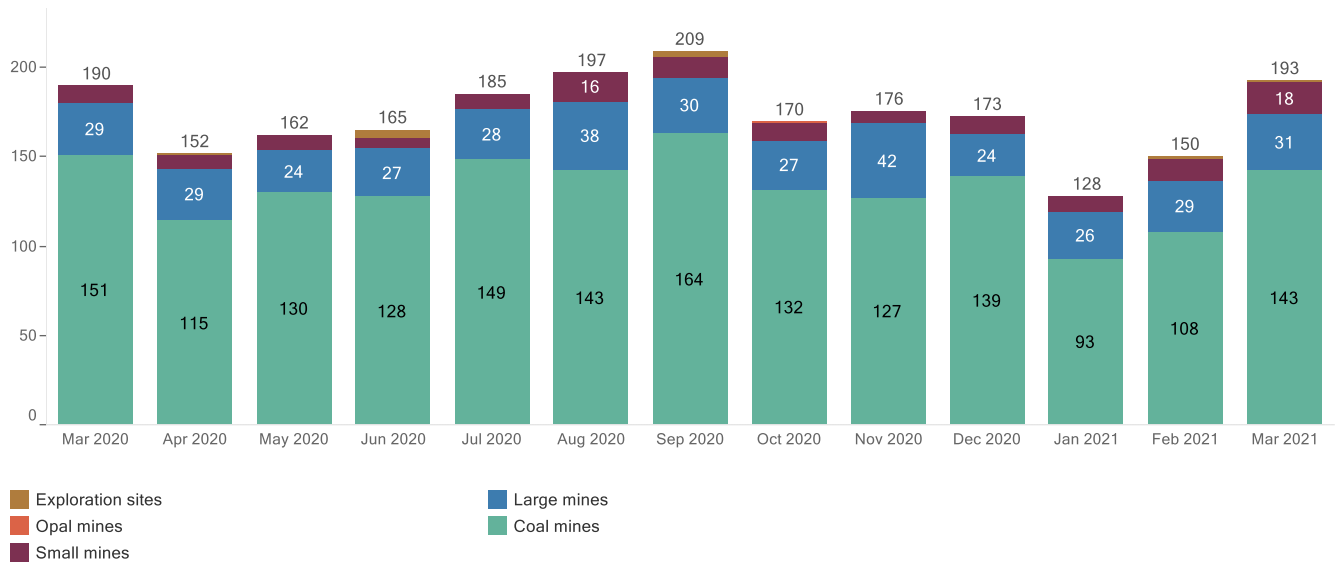

DATE NOTIFIED	REPORTING SECTOR	PRINCIPAL MINING HAZARD	INCIDENT
1 Mar	Large mines – Metalliferous and Quarries	Loss of control of lifted load or load lifting equipment	A worker sustained a laceration that required stitches when a broken chain-link became a projectile and hit the worker on the side of the head. Workers were lifting a wing on a jaw crusher when one of the lifting chains snapped.
4 Mar	Coal mines	Ground or Strata Failure	A roof fall occurred at an intersection in an underground coal mine. The fall was in an outbye area of the mine and extended into the cut-through, blocking the travel road. All personnel were safely evacuated and there were no injuries.
5 Mar	Coal mines	Fire and Explosion - Surface	An excavator operator jumped clear of the cabin to escape a fire that engulfed his machine. The operator did not have time to activate the fire suppression system and the cabin was destroyed. The position and extent of the fire indicates catastrophic engine failure, potentially caused by ruptured fuel or oil lines outside the engine envelope. The fire propagated forward towards the fuel tank, with evidence of significant heat around the main boom pivot. The excavator recently underwent a major overhaul.

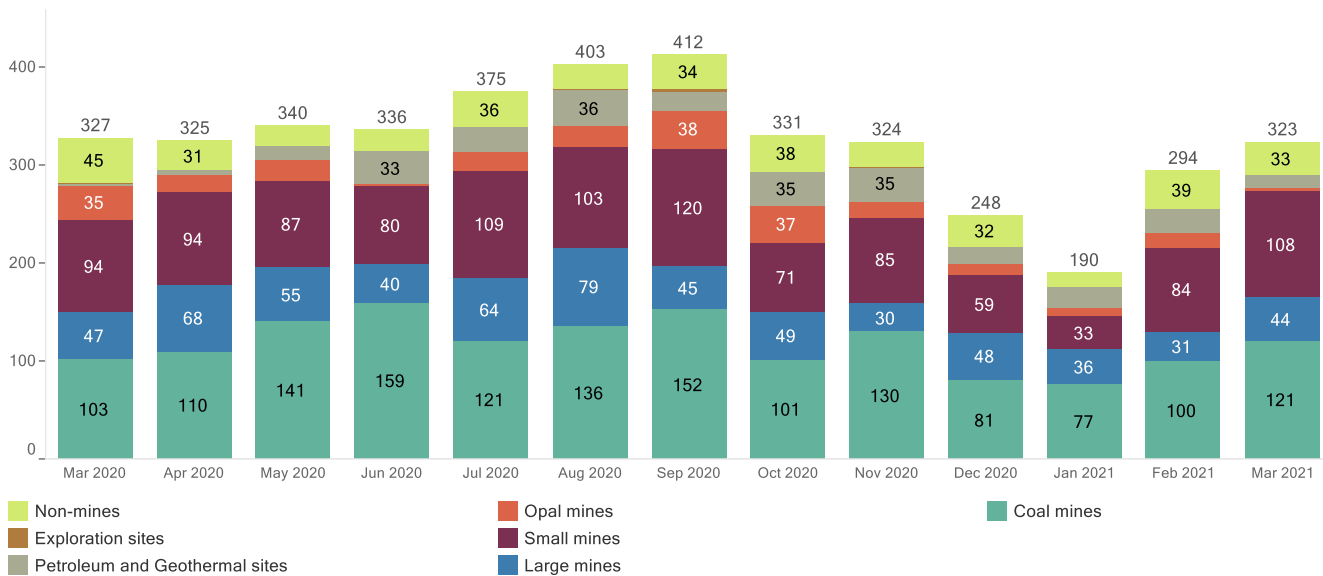

6 Mar	Coal mines	Surface vehicle interaction - Roads and Vehicle other operating areas	While working on a haul road, a grader operator performed a u-turn. The position 2 tyre of the grader contacted the position 3 tyre of a haul truck that was overtaking the grader at the time. The grader operator did not look to see if the road was clear before initiating the u-turn. The haul truck operator had followed the correct procedure for overtaking.
11 Mar	Coal mines	Surface vehicle interaction - Roads and Vehicle other operating areas	A dozer and a haul truck collided at a tip head. Both vehicles were reversing at the time of the incident. A preliminary investigation suggests that the truck operator did not follow the site requirement for positive communications with the dozer operator.
11 Mar	Large mines – Metalliferous and Quarries	N/A	A worker sustained a compound fracture to their leg during the removal of a bucket from an excavator. The bucket holding pin was being pushed from one side of the bucket by a pin pusher attached to a loader. The pin was almost free of its housing when the operator moved to the other side of the bucket, the pin came free, bounced off the bucket and hit the operator on the leg.
13 Mar	Coal mines	Surface vehicle interaction - Roads and Vehicle other operating areas	A dozer tipped on its side while in the process of levelling a windrow. The operator was able to exit the machine and sustained no injuries.
15 Mar	Large mines – Metalliferous and Quarries	Abnormal movement of excavated / surface strata	A fall of ground occurred across a haul road approximately 300 metres above the mine portal. Two operators were unable to drive out of the pit due to the ramp being blocked. There were no injuries.
15 Mar	Coal mines	Fire and Explosion - Underground	Increasing water levels at longwall maingate restricted ventilation resulting in gas exceedance of greater than 2% methane.
26 Mar	Coal mines	Fire and Explosion - Surface	Two workers suffered nausea and headaches after taking about 30 minutes to extinguish a fire on a compressor. The compressor was on the mine surface, however, the workforce was withdrawn from underground as a precaution. Repairs had recently been completed to the compressor and it was deemed fit to continue in operation.

DATE NOTIFIED	REPORTING SECTOR	PRINCIPAL MINING HAZARD	INCIDENT
28 Mar	Coal mines	Loss of control of lifted load or load lifting equipment	A fitter received a severe laceration to their left cheek while removing a cross-member from the engine bay of a haul truck. Two fitters were removing the cross-member by jacking from below and lifting with a crane. The injured worker was reportedly moving electrical cables from the path of the cross-member when it came loose. The tension applied by the slings, combined with the pressure from the jack, allowed the cross-member to rise-up quickly and strike the fitter. The incorrect procedure was being used for the task.
29 Mar	Coal mines	Surface vehicle interaction - Roads and Vehicle other operating areas	A dump truck was reversing towards an excavator. The rear of the dump truck has made contact with the excavator's access ladder at approximately cabin height. There were no injuries.

Proactive and reactive safety assessments

Proactive assessments include targeted assessments and planned inspections. Assessments conducted in response to incident notifications, targeted interventions, high risk activity notifications and action requests are reported as reactive assessments.

In March 2021, 43% of all site and desktop safety assessments were proactive. Of the 177 site assessments conducted, 77% were proactive.

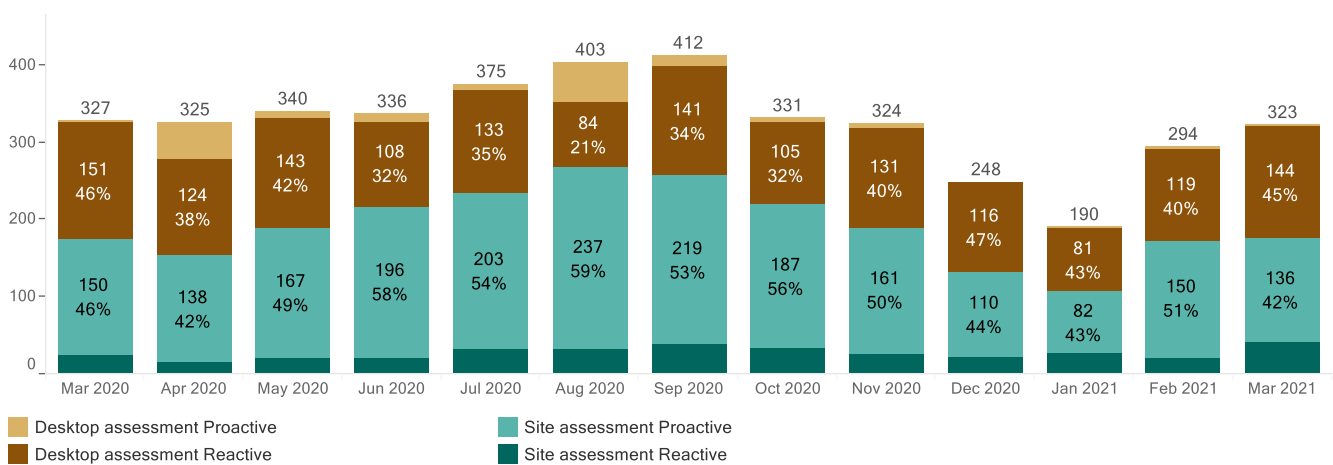
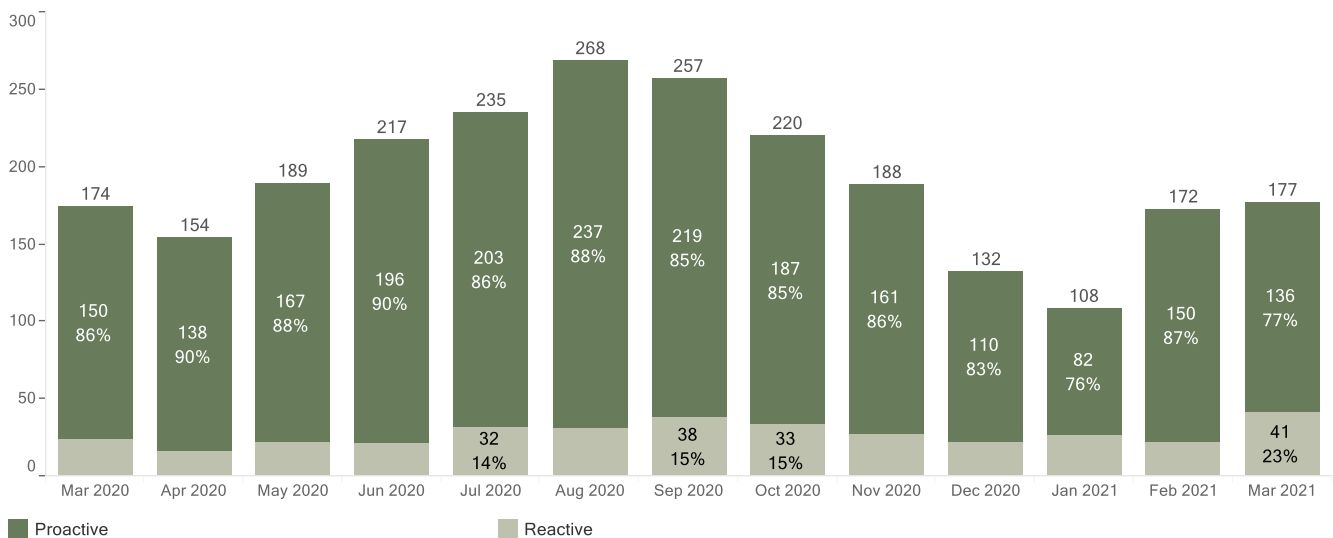


FIGURE 4. SAFETY SITE ASSESSMENTS COMMENCED BY NATURE – MARCH 2020 TO MARCH 2021

FIGURE 5. TARGETED SAFETY SITE ASSESSMENTS COMMENCED – MARCH 2020 TO MARCH 2021

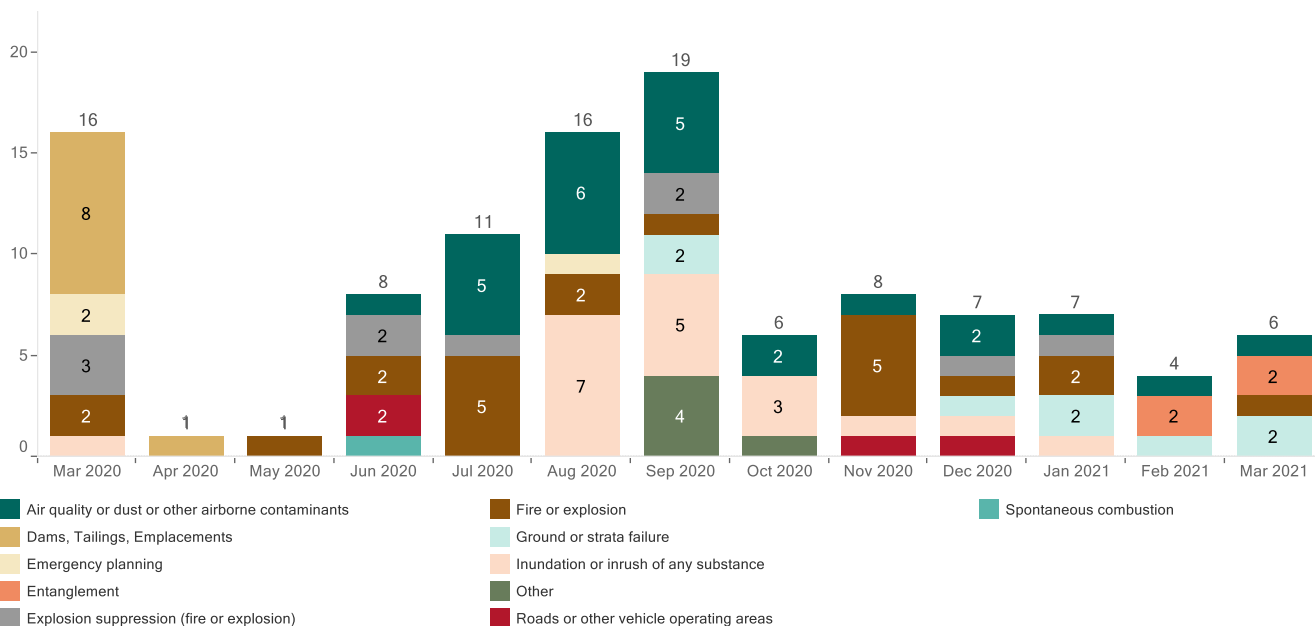

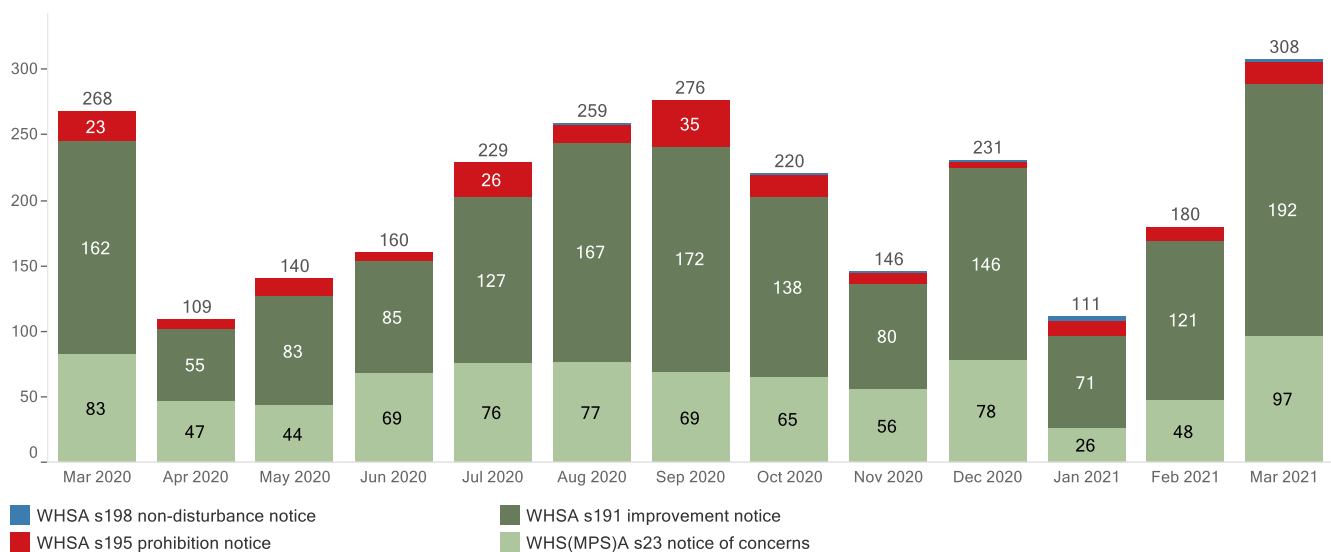

Safety compliance activities

Safety notices issued

In March 2021, we issued 308 statutory notices under the *Work Health and Safety Act 2011* which were 192 improvement notices, 97 notice of concerns, 17 prohibition notices and two non-disturbance notice.

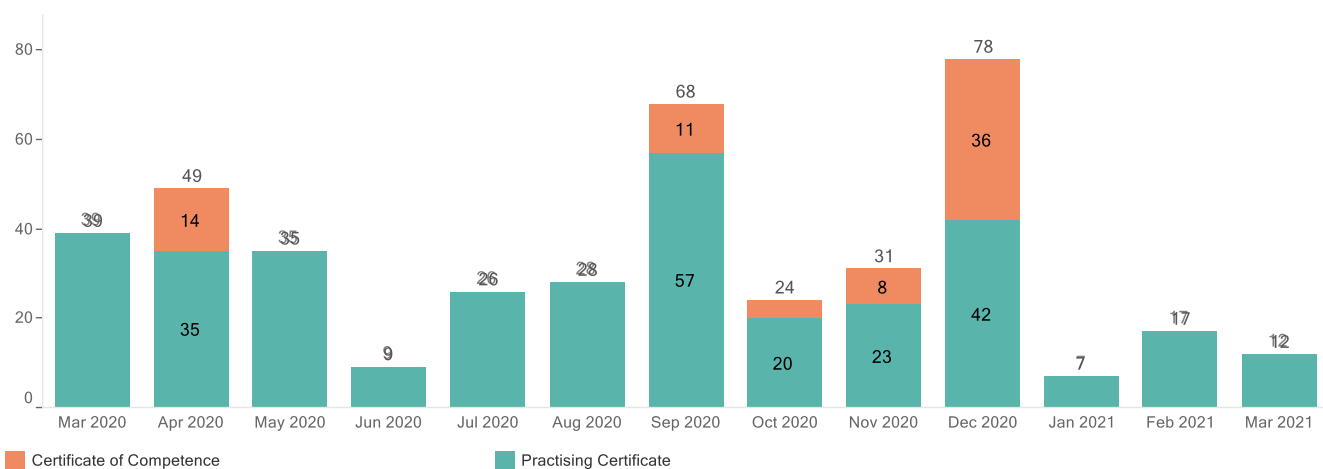

Safety mining competence activities include certificate of competence (mutual recognition). In March, we granted 12 practising certificates.

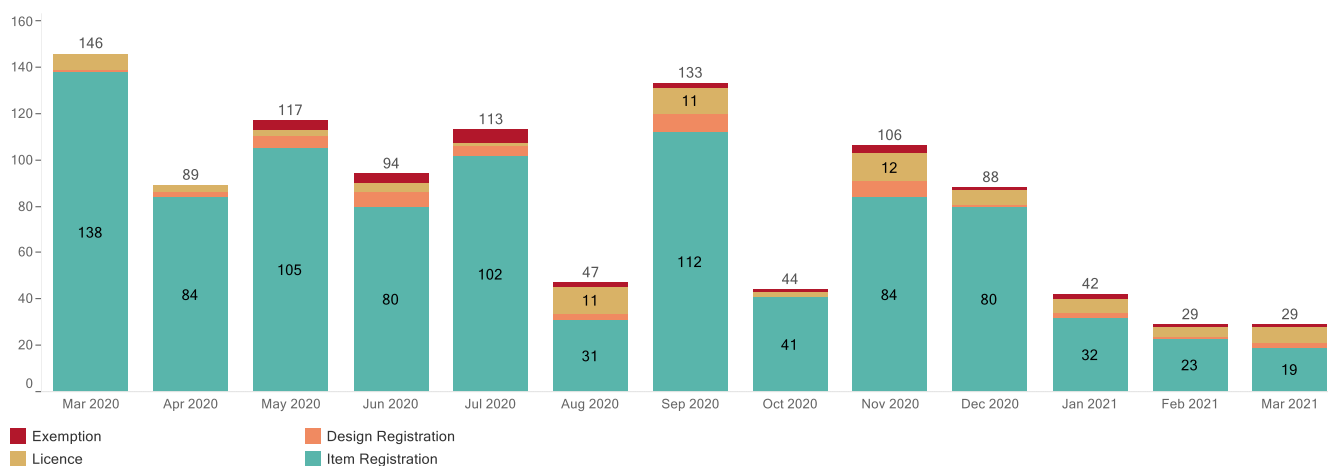
FIGURE 7. COMPETENCE AND PRACTISING CERTIFICATES GRANTED – MARCH 2020 TO MARCH 2021

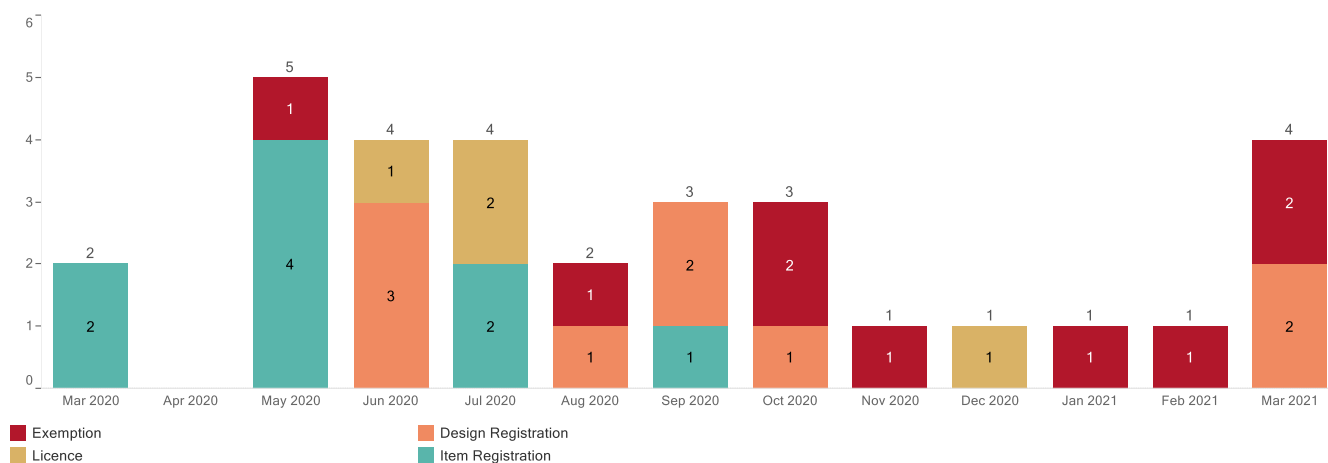

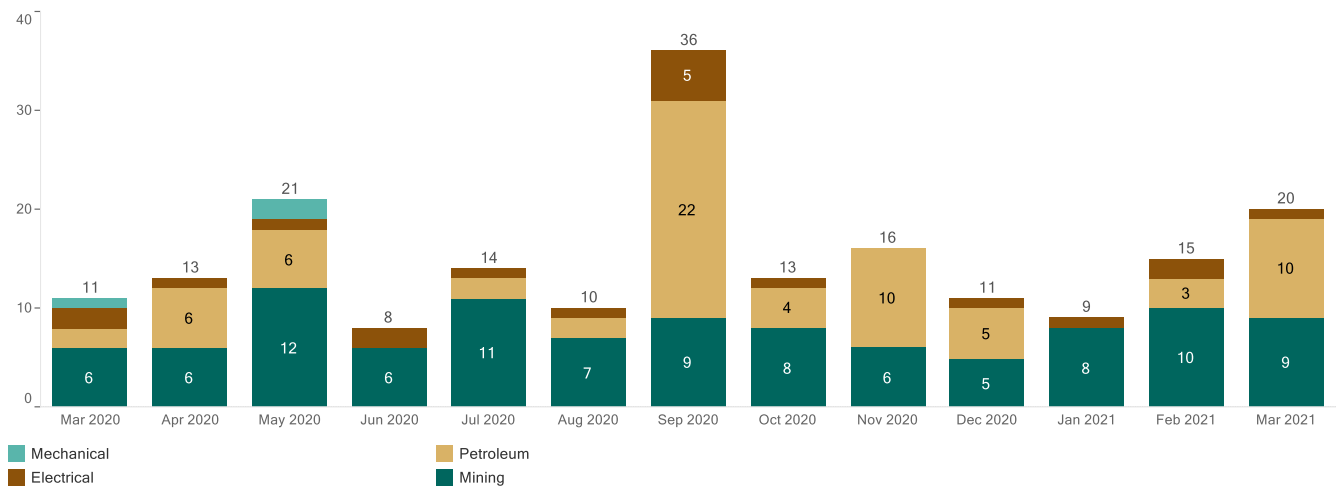

Reactive site assessments include assessments conducted in response to lodgement of mining operation plans, annual reports, security reviews, applications to conduct exploration activities, title dealings and action requests.

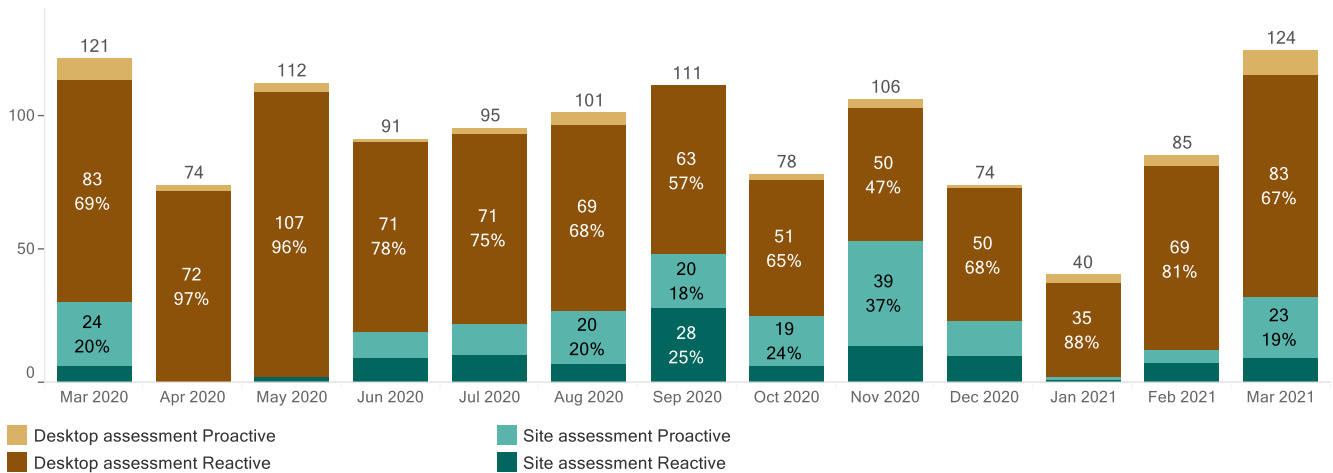
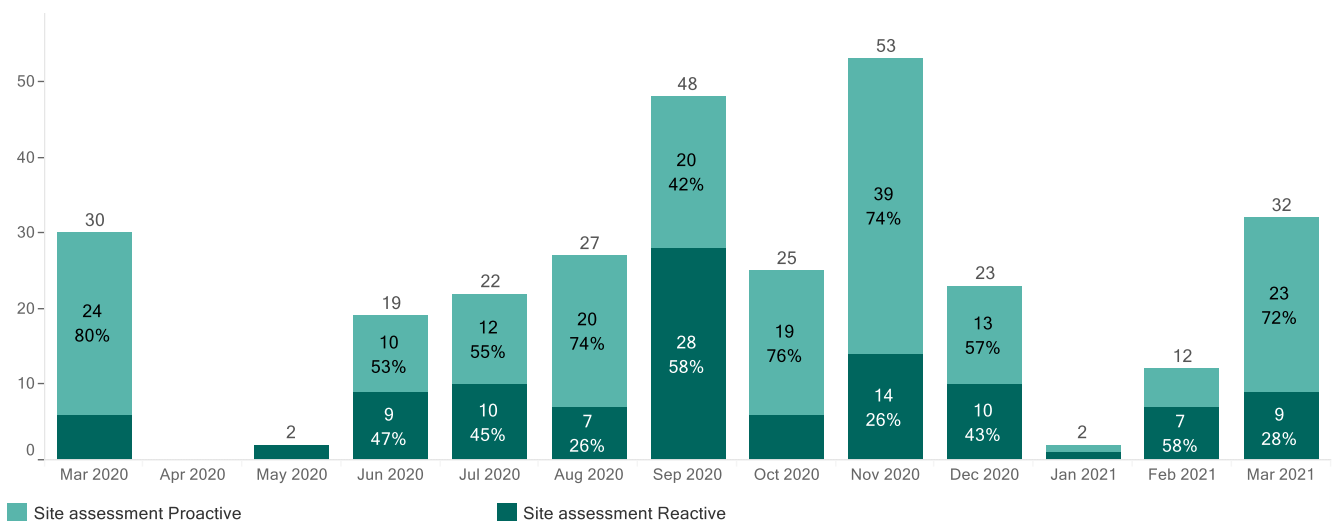


FIGURE 12. MINING ACT SITE ASSESSMENTS COMMENCED BY NATURE – MARCH 2020 TO MARCH 2021

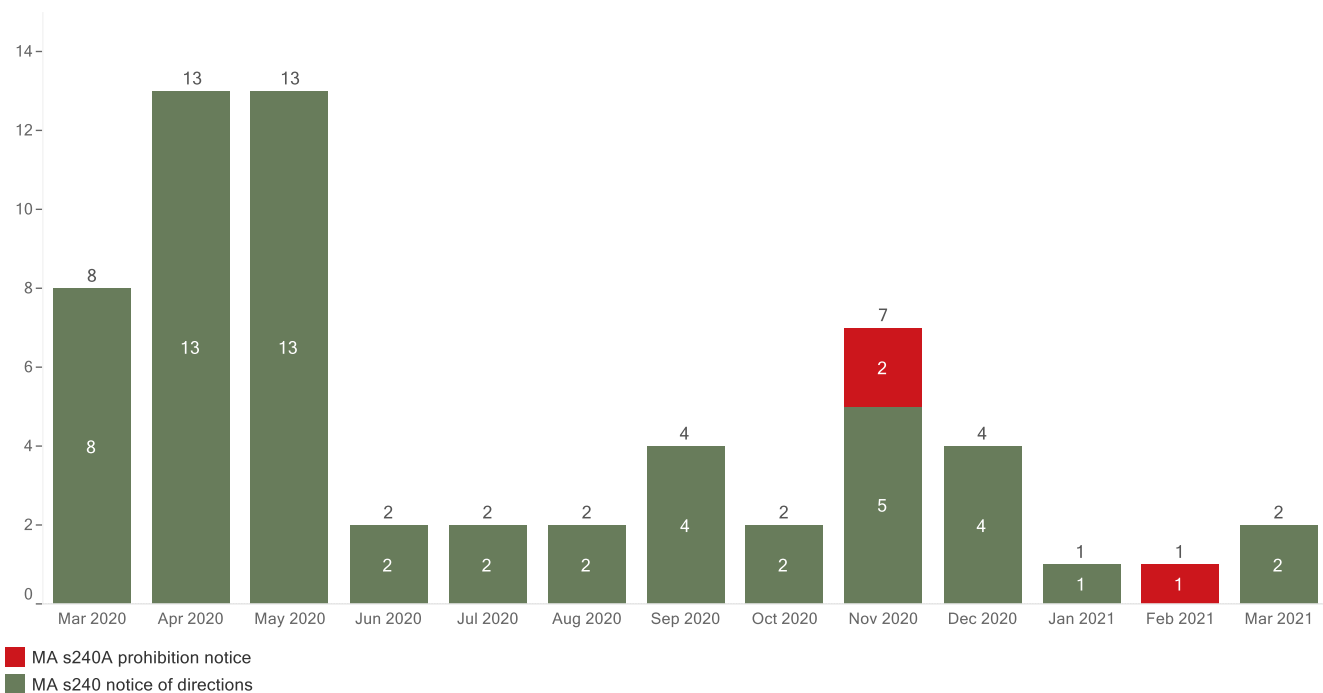

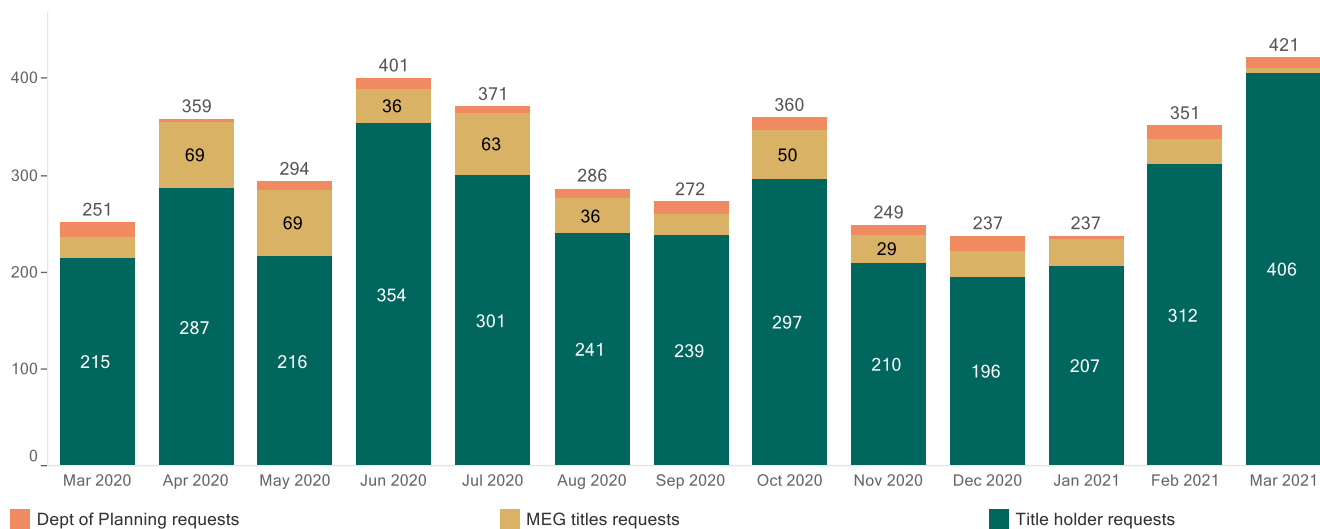

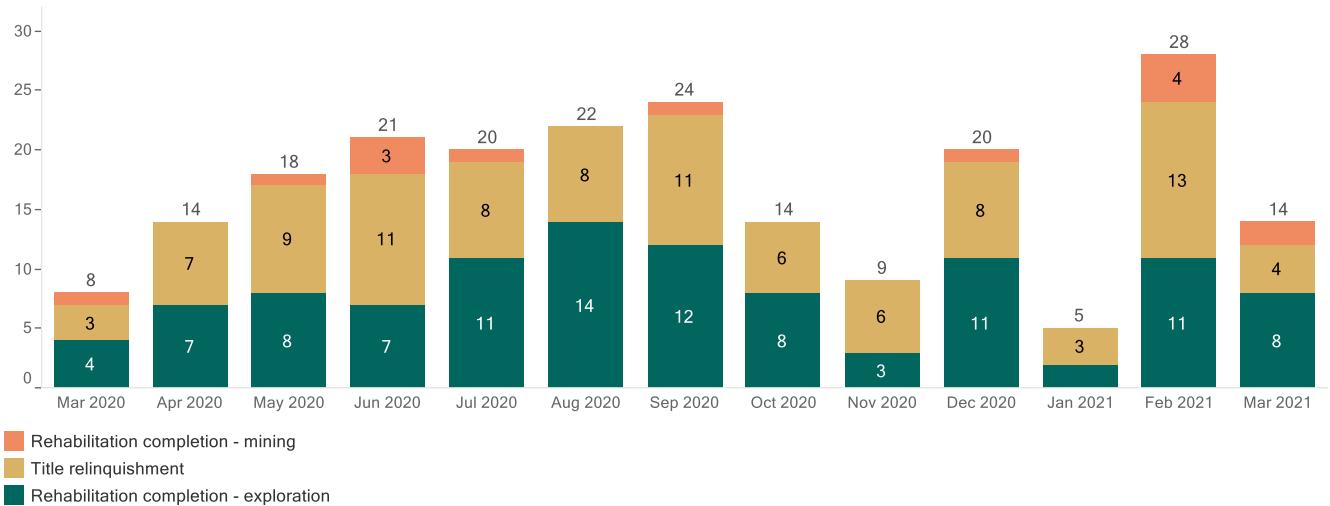

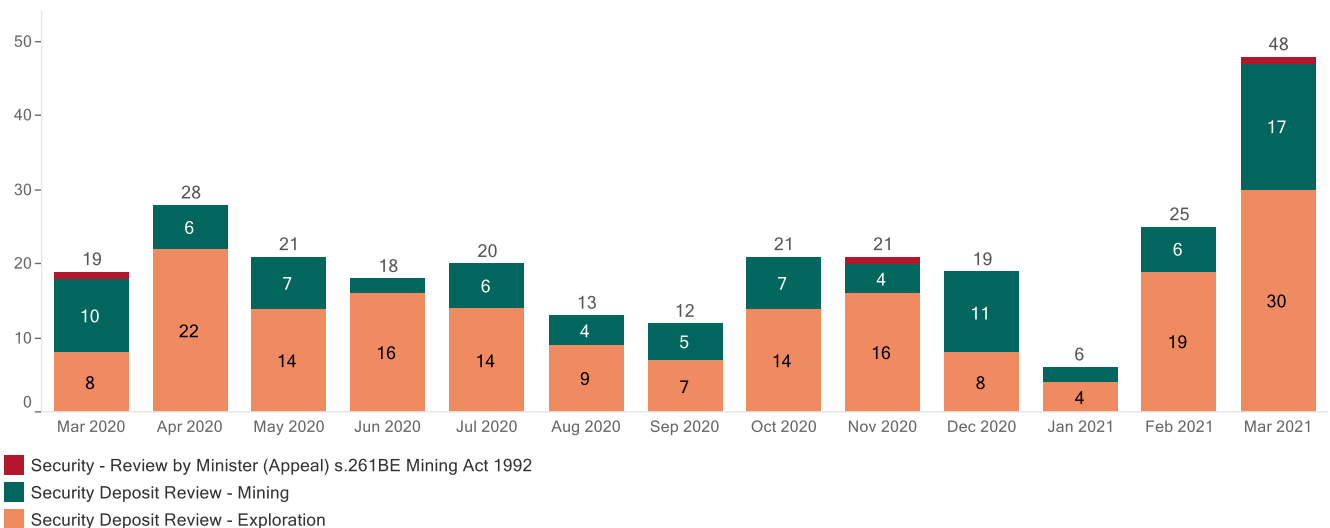
FIGURE 15. MINING ACT REHABILITATION COMPLETION ACTIONED – MARCH 2020 TO MARCH 2021



Rehabilitation security deposit review

Our inspectors regularly assess the surface disturbance (or proposed disturbance) of a mine or exploration site to calculate the security deposit. This is known as the assessed deposit. Once the assessed deposit is determined, we advise the Mining, Exploration and Geoscience (part of Regional NSW), who vary the condition of the title and seek the additional funds - or in the case of satisfactory rehabilitation, returns some or all of the security deposit.

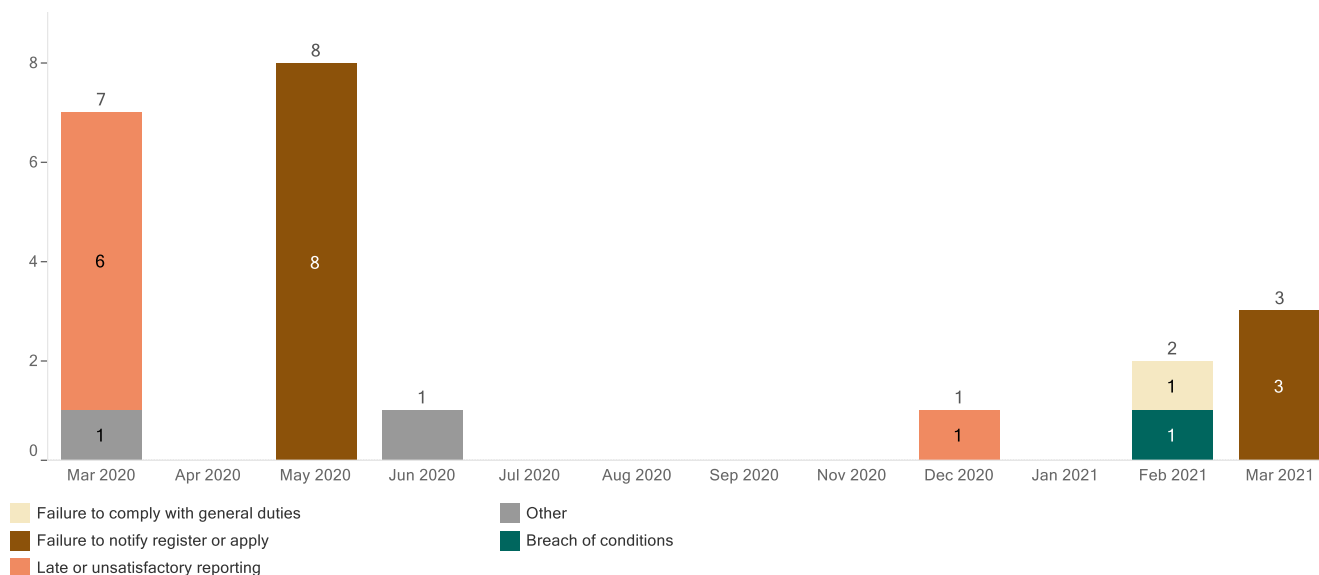

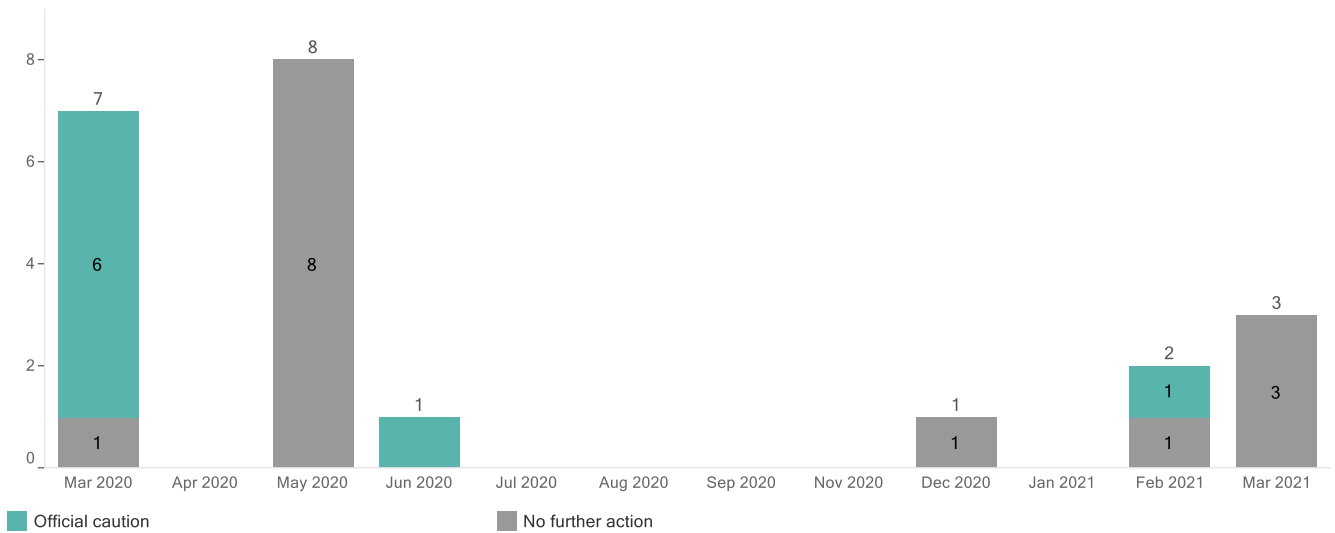

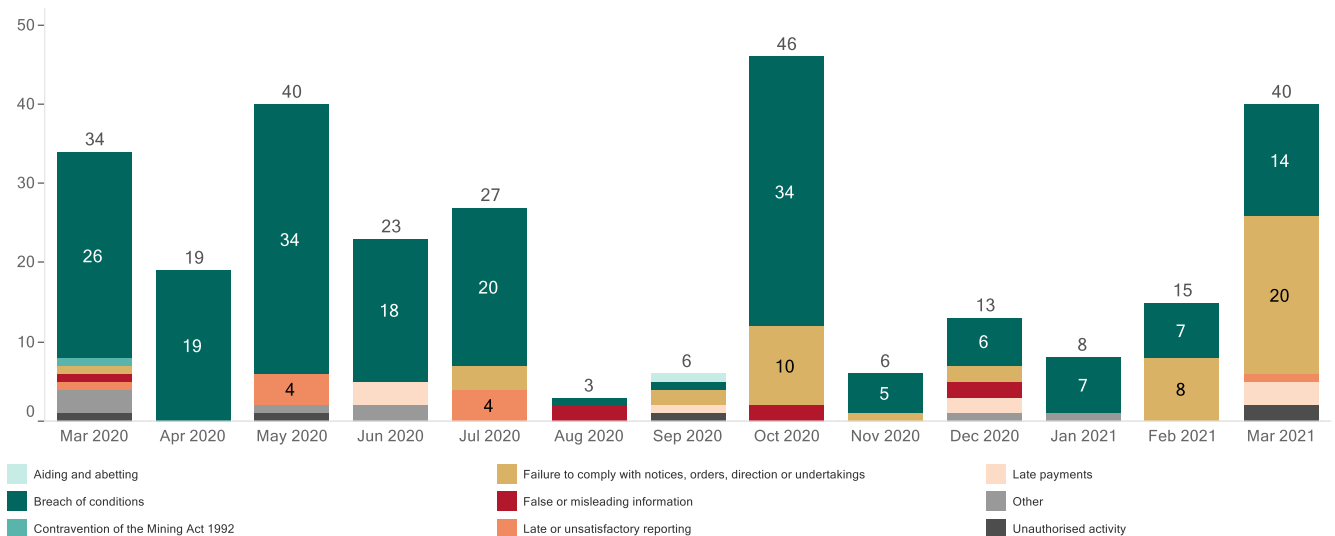

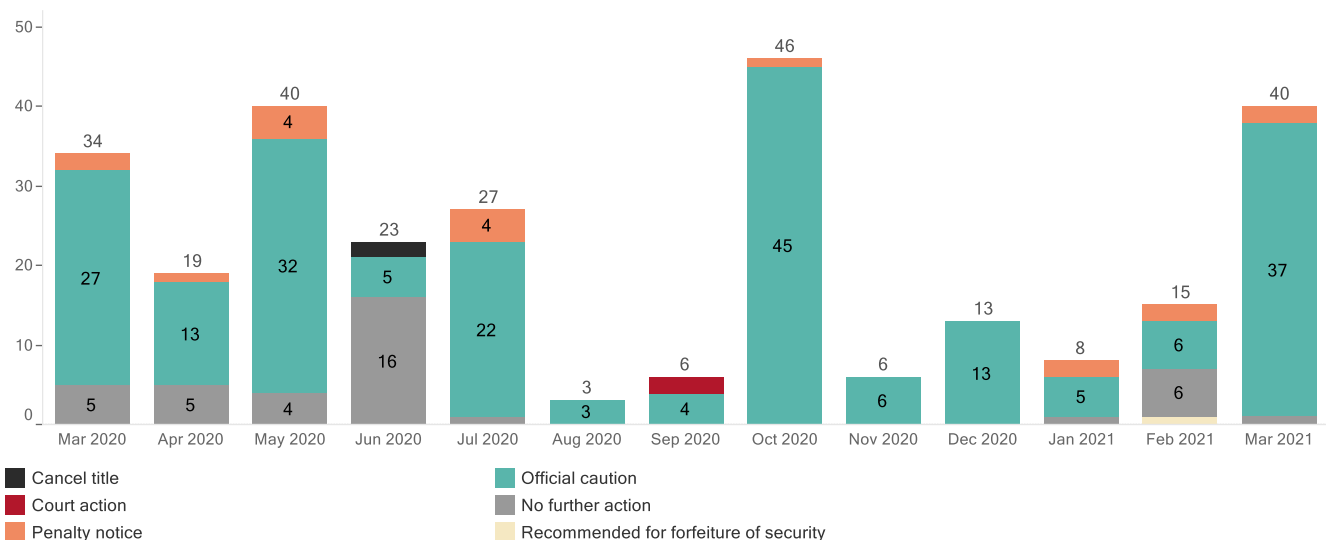
